

**MINUTES  
OWLS HEAD BOARD OF SELECTMEN  
MARCH 5, 2019**

**1. Call the Meeting to Order**

Thomas R. Von Malder called the meeting to order at 4:00PM in the Selectmen's Meeting Room. Present were selectmen Linda Post and Gordon Page. Also present was Joan Linscott, recording and members of the public (see attached sign in sheet).

**2. Approve the Minutes of the Feb. 19, 2019 Selectmen's Meeting**

**Motion: Gordon Page to approve the minutes as presented. Linda Post seconded.**

**VOTE: 3 in favor – 0 opposed**

**3. Old Business**

**Thomas R. Von Malder** – Asked if there was any resolution to the Cooper's Beach Road plowing yet?

**Gordon Page** - Has not had time to get there yet, so not sure what is happening.

**4. New Business**

**a.) Meet with and appoint State Certified Animal Control Officer William Demmons to fill the ACO position for the Town of Owls Head**

Unfortunately Mr. Demmons could not attend this evening.

**Gordon Page** – Are we going to get to meet Mr. Demmons? Are we sure he wants the position? What is his rate of pay going to be?

**Thomas R. Von Malder-** We will be paying him the same amount as Gordon Poland for now since we are already in the budget year. We can not increase this now.

**Linda Post** – Feels we need to look at this pay for the next budget, we did increase the pay for the Road Commissioner last year.

**Gordon Page** – Is willing to second a motion but will oppose the appointment only due to fact he would like to meet Mr. Demmons and interview him before doing an appointment.

**Motion: Linda Post to appoint William Demmons as Animal Control Officer at the same rate as we were paying Gordon Poland for his remaining term. Gordon Page seconded.**

**VOTE: 2 in favor – 1 opposed (Gordon Page)**

**a.) Open the bids on the Harbor Park Project**

**Because of the possibility of inclement weather this item has been moved to the agenda for March 18th**

**b.) Approve the rental of the upstairs for the Harbour Hill Association on April 27th at a reduced rate of \$25.00**

**Linda Post** – Why would we be charging these folks when it was always set to allow Owls Head residents to use the building at no charge as long as it was not the kitchen. We do not charge the Bridge Club to use the upstairs.

**Thomas R. Von Malder** – They use it during the week when the office is open and Terry does not have to come and open the building.

**Linda Post** – Does not believe that Terry gets paid extra to come to the building to open it up.

**Motion: Linda Post to allow the Harbour Hill Association to use the upstairs at no charge on April 27, 2019. Gordon Page seconded.**

**VOTE: 3 in favor – 0 opposed**
